

**SUMMARY ANNUAL REPORT FOR  
Lam Research Corporation Group Welfare Benefit Plan**

This is a summary of the annual report of the Lam Research Corporation Group Welfare Benefit Plan (Employer Identification Number 94-2634797, Plan Number 501) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Lam Research Corporation has committed itself to pay certain medical, prescription drugs, dental, vision, temporary disability and FSA claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with ACE American Insurance Company, Anthem Blue Cross Life and Health Insurance Company, ARAG Insurance Company, Blue Cross of California, CIGNA Health and Life Insurance Company, Kaiser Foundation Health Plan Inc, Kaiser Foundation Health Plan of the Northwest, Optum Health & Technology US LLC, Standard Insurance Company and Metropolitan Life Insurance Company to pay certain life, accidental death and dismemberment, medical, dental, vision, long-term disability, business travel accident, legal, employee assistance program, critical illness, accidental injury and hospital indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$36,829,206.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$10,222,763 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$8,137,176.
